



**GENERAL INTERNATIONAL AGREEMENT
for
ACADEMIC COOPERATION PROTOCOL
between

and
UNIVERSIDAD NACIONAL AGRARIA LA MOLINA, PERU**

Niğde Ömer Halisdemir University, Niğde, Turkey and Universidad Nacional Agraria La Molina, Peru, establish this General Agreement to foster international cooperation in education and research.

Parties

Item 1



This academic Cooperation Protocol has been signed between Niğde Ömer Halisdemir University, Niğde, Republic of Turkey represented by its Rector Prof. Dr. Muhsin KAR and Universidad Nacional Agraria La Molina represented by its Rector Prof. Dr. Enrique Ricardo Flores Mariazza.

Purpose

Item 2

Nigde Omer Halisdemir University and Universidad Nacional Agraria La Molina have an established history and mutual interest in promoting education, research, exchange, and training. Additionally, each institution would like to learn from the other, in a spirit of friendship, equality and mutual interest, to enrich the understanding of its two cultures.

Duration

Item 3

1. This protocol will be valid for a five -year (5 year) period after the signature dates of both parties unless one of the parties cancels it. The parties intend to review this Protocol every five years to evaluate the progress and the quality of the mutual cooperation.
2. This protocol may be terminated by either party with a minimum of 60 days written notice. Activities in progress at the time of termination of this Agreement shall be permitted to conclude as planned unless otherwise agreed.

Responsibilities of the parties

Item 4

1. Both parties agree to encourage the following activities, in particular to promote international academic cooperation:
 - a) Exchange of materials in education and research, publications, and academic information;
 - (b) Exchange of faculty and research scholars;
 - (c) Joint research and meetings for education and research;
 - (d) Technical Assistance;
 - (e) Student mobility.

Before these activities can be implemented, both parties shall discuss the problems involved to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the relationship.



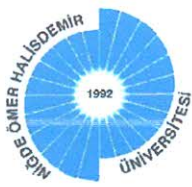
2. This Protocol Agreement shall be applicable to each party's research institutes, educational centres, and other subsidiary institutions or campuses.
3. All research and other collaborative activities conducted pursuant to this agreement shall be conducted in accordance with the laws and regulations appropriate to each institution.

4. This Agreement is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process for teaching, research and outreach activities.

5. This General Agreement shall become effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.

6. Both institutions subscribe to a policy of equal opportunity, non-discrimination and affirmative action. University programs, activities and facilities are available to all without regard to race, colour, gender, religion, national origin, political persuasion, sexual orientation, marital status, disability, height, weight, veteran status, age or familial status.
