
#### AGREEMENT OF UNDERSTANDING





## UNIVERSIDAD NACIONAL AGRARIA LA MOLINA



### AND

#### YAMAGUCHI UNIVERSITY

In order to improve the scientific and educational level of the two institutions, to promote and intensify the friendship and the mutual understanding between peoples in general and Faculties in particular, UNIVERSIDAD NACIONAL AGRARIA LA MOLINA and YAMAGUCHI UNIVERSITY, desire to establish relationships in scientific and cultural fields in an institutional framework and have agreed as follows:

- Article 1. Both universities agree to encourage the development of the following exchange and cooperation based on their respective academic and educational needs.
  - (1) Exchange of faculties and administrative staff members
  - (2) Exchange of undergraduate and graduate school students
  - (3) Cooperation in undergraduate and graduate school education and training
  - (4) Exchange of academic information and materials
  - (5) Organization of joint research programs, joint conferences, symposiums and other scientific meetings on subjects of common interest.
  - (6) Other exchange and cooperation programs that both universities agree to.



- Article 2. This Agreement is not intended to create binding or legal obligations on either party. When details of any of the above activities are developed mutually, such details will be set forth in agreements supplemental to this Agreement.
- Article 3. Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.
- Article 4. This agreement has come into effect from June 6, 2022, and shall be valid for a period five years. The Agreement of Understanding may be extended upon specific agreement. Either party may terminate the Agreement of Understanding by giving six months advance written notice to the other party.
- Article 5. Universidad Nacional Agraria La Molina nominates as a Coordinator of this agreement to professor Dr. Christian Encina Zelada as ORI's Director.

Yamaguchi University nominates as a Coordinator of this agreement to professor Dr. ISHII Yuri.

Article 6. Should on-going collaborative activities be affected by termination, the parties undertake to resolve any issue amicably by mutual agreement.

Article 7. This Agreement is drawn up in English and both universities have copies of it.

# STUDENT EXCHANGE AGREEMENT BETWEEN UNIVERSIDAD NACIONAL AGRARIA LA MOLINA AND YAMAGUCHI UNIVERSITY



Universidad Nacional Agraria La Molina and Yamaguchi University agree as follows in order to ensure the smooth implementation of student exchange of both universities according to Article 1 Point 2 of the Agreement of Understanding between Universidad Nacional Agraria La Molina and Yamaguchi University, which both universities conclude.

#### 1. Eligible Exchange Students

Undergraduate students and graduate students of both universities are eligible.

#### 2. Reception Period

An exchange student's reception period is limited to two semesters (to one year).



#### 3. Number of Exchange Students

Both universities can recommend up to "five" exchange students every year. The number should be decided by deliberations between both universities. Both universities will attempt to exchange students on a one-to-one equal exchange for a period as agreed by the both universities. If an unequal exchange ratio occurs in any period, a balance will be attempted over the following two to three year period or the exchange will be reviewed.

#### 4. Selection of Students



Each university has a responsibility to decide an exchange student's entrance formalities independently. Selection of an exchange student considers their obtained grade as a priority. The exchange student who is recommended has to meet the admission standards of the host university, and he/she has to have both adequate knowledge of the subject and other study capability. Each university has the right of determination of acceptance of the recommended exchange student.

#### 5. Status of Exchange Students

The status of the exchange student is non-degree student. The exchange student does not have the degree conferment qualification of the host university.

#### 6. Acquisition of Credits and Grades

The home university can accept the credits and grades which the exchange student acquired at the host university as official grades according to the home university's regulations.

#### 7. Subjects of Student

In consideration of an exchange student's study situation, both universities determine the subjects.

#### 8. Tuition, Entrance Fee, and Examination Fee

Both universities shall not charge exchange students tuition fees, entrance fees and examination fees.

#### 9. Necessary Expenses

Necessary expenses, such as travel expenses, accommodation fees, living expenses, and medical insurance, are taken as an exchange student's burden.



#### 10. Insurance

Exchange students are responsible for contracting their own medical insurance in accordance with the policy of the host university, and to provide proof to the host university upon request.

#### 11. Accommodations

Both universities should make the maximum effort to obtain an exchange student's accommodations.

#### 12. Other Points

Regarding the procedure for studying abroad and the acquisition of a study-abroad visa, both universities should provide all possible services for exchange students.

#### 13. Amendments to or Cancellation of the Agreement

Both universities may discuss the terms set forth in this agreement at any time if needed. If a situation which requires the correction or repeal of this Agreement arises, each university must notify the other party by letter six months in advance.

#### 14. Term of the Agreement

This Agreement is drawn up in English and both universities have copies of it. The term of validity of this Agreement is the same period in accordance with the "Agreement of Understanding between Universidad Nacional Agraria La Molina and Yamaguchi University".
