

**MEMORANDUM OF UNDERSTANDING ON EXCHANGES BETWEEN**  
**VETAGRO SUP, INSTITUTE FOR HIGHER EDUCATION AND RESEARCH IN FOOD, ANIMAL**  
**HEALTH, AGRICULTURAL AND ENVIRONMENTAL SCIENCES, FRANCE**  
**AND**  
**UNIVERSIDAD NACIONAL AGRARIA LA MOLINA, PERU**

In order to encourage academic exchange and collaboration between our two institutions, and to advance teaching and research in our respective institutions, **VetAgro Sup, Institute for Higher Education and Research in Food, Animal Health, Agricultural and Environmental Sciences**, 1 avenue Bourgelat, 69280 Marcy l'Etoile, France, duly represented by its **Dean, Dr Mireille BOSSY**, established by decree of the President of the French Republic dated 22 November 2021, NOR : AGRS2132019D; and **Universidad Nacional Agraria La Molina**, with RUC 20147897406, with legal address at Av. La Molina s/n, District of La Molina, Department and Province of Lima, Peru, duly represented by its **Rector Dr. Américo Guevara Pérez**, whose DNI is 10538747, established by its Resolution N°001-2021-AU-UNALM (hereinafter referred to as "both universities") make the following agreement:

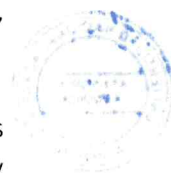
1. Both universities agree to develop and pursue the following cooperative educational and research activities:
  - 1.1 exchange of teaching and research staff
  - 1.2 exchange of administrative and other professional staff
  - 1.3 exchange of students
  - 1.4 collaboration on research projects
  - 1.5 collaboration on academic publications, data, and information
2. Each university, based on a deep and abiding respect for the other's regulations and systems, agrees to carry out these activities following full consultation with and approval by the other. Specific agreements will be signed by each university to frame these activities. They will all contain:
  - A description of the project;
  - A duration clause;
  - A clause which indicates name of responsible for each party.
3. Each institution shall designate a coordinator to oversee and facilitate the implementation of this MOU:

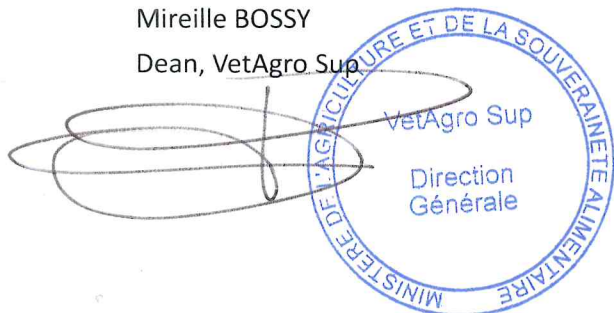
4. The parties agree to specify that both the execution and the implementation of this Agreement will not generate financial resource transfers, but rather effective collaboration that contributes to the fulfilment of their objectives.
5. Any individual participating in the exchange program will be responsible for their living expenses, accommodation, travel and visa costs, medical insurance, accident insurance, repatriation, corresponding academic fees, materials, books, administrative processing fees, and other personal expenses.
6. Any issues regarding intellectual property rights that arise as a result of any collaborative research or activity under this memorandum of understanding will be detailed on a case-to-case basis and in a manner consistent with the intellectual property rights policies of both universities.
7. This memorandum is effective from the date signed for a duration of five (05) years. It may be renewed by mutual consent, if proposed by either party.
8. This memorandum may be amended or terminated by mutual consent, if proposed by either party. For the amendment or termination, either party should give six months' written notice to the other party.
9. All information exchanged by the parties for the formation and execution of this memorandum of understanding constitutes confidential information which shall not be disclosed to third parties during the term of the agreement and for the following 5 years, except by court order, request, or inspection by public bodies or entities that require it.
10. In the event of disagreement or dispute over the execution of this memorandum, the parties shall meet to settle the situation amicably. In the event that the situation persists and a party brings an action before the courts, the applicable law will be that of the defendant.
11. This memorandum shall be officially executed in English.
