

Memorandum of Agreement

between

Universidad Nacional Agraria La Molina

and

Weatherpia Co., Ltd.

On

Research Collaborations and the Knowledge Partnership

This Memorandum of Agreement (MOA) is made and entered into by and between **Universidad Nacional Agraria La Molina** (UNALM), represented by its Rector, Dr. Américo Guevara Pérez, who holds this position by virtue of Resolution No. 001-2021-AU-UNALM; UNALM is located at Avenida La Molina (no number), District of La Molina, Lima, Republic of Peru – RUC 20147897406 and the CEO Sangwook LIM, **Weatherpia Co., Ltd.**, entity located at Inyoung Building, 34, Uisadang-daero 1-gil, Yeongdeungpo-gu, Seoul, 07333, Republic of Korea, (hereinafter referred to individually as “the party” and collectively as “the parties”).



SUPPORTING, Universidad Nacional Agraria La Molina for objective stated in Article 1 and shall explore synergies between the two organizations in the field of hydrometeorological research, environmental protection, climate information system and services as well as other climate change issues.



ACKNOWLEDGING that there is a great need for close cooperation among the Parties for the research collaboration and utilizing talented workforces in the Universidad Nacional Agraria La Molina, both parties have agreed as follows:



Article 1

Objectives

The objective of this MOA is to share and disseminate knowledge and experience, including the development of joint R&D and policy consultation with party and to support the Enhancement of Climate Information Services and Capacity building for

Climate Change Monitoring and Prediction for Climate change adaptation in Peru in the long-term relationship.

Article 2

Basic Principles

Each Party will collaborate and cooperate based on the principles of mutual respect and understanding and make its best efforts to comply with the provisions of this MOA in good faith.

Article 3

Areas of Cooperation

Each Party will advance the following areas of cooperation, and any specific information regarding the following matters will be determined upon mutual consultation among the Parties:

1. Raising awareness about meteorological data and climate information services for climate change adaptation in Peru, as well as developing related plans;
2. Information and knowledge sharing activities on matters related to research (e.g., joint R&D) and research capacity through a network of consultants, experts, and specialists relevant to the work of the two parties. Further, Communication channels with Korean universities, Korean government organizations regarding meteorological and climate change will be provided;
3. Supporting organizations of workshops, seminars, training courses, and events on topics related to hydrology and meteorology and reflecting on appropriate actions;
4. Implementing the cooperation structure to efficiently carry out projects from International Organizations (e.g., UNDP, WB, ADB, GCF, UNEP, etc.);
5. Any other matters necessary for the mutual development of the Parties.



Article 4

Agreement

In order to carry out the mutual activities, the parties will elaborate individual agreements that contains the specific proposals of collaboration and a plan of operation developed to execute this MOA. These agreeable plans must have the approval of the appropriate authorities in Peru and Partner University.



The Plan of Operation will include such items as:

- a. Elaboration of the responsibilities of each institution for the agreed upon activities;
- b. Schedules for the specific activity;
- c. Budgets and sources of financing for each activity; and
- d. Any other items deemed necessary for the efficient management of the activity.

Article 5

Working Group

For the purposes of efficient implementation of the areas of cooperation as set forth in this MOA and mutual consultation among the Parties with respect to specific tasks, the Parties may establish and operate a working group consisting of relevant representatives of the Parties responsible for such tasks.

1. All matters regarding the establishment and operation of a working group will be separately negotiated and agreed between the Parties.
2. The working group may meet at any time each Party deems necessary in its sole judgment.

Article 6

Funding

This MOA is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process, research relationship, and so forth.



All activities outlined in this agreement shall be contingent upon the successful securing of external funding. Both parties shall actively collaborate in efforts to secure the necessary financial resources. The institution submitting a project proposal shall be responsible for ensuring the availability of sufficient funding to support the full execution of the project.

Article 7

Confidentiality

Each Party shall maintain the confidentiality of any oral or written information exchanged between the Parties in connection with the preparation and performance of this MOA, and without obtaining the written consent of the other Party, it shall not disclose, disseminate and publish such confidential information to any third parties, except for the information that is in the public domain.

Article 8

Use of Brand Identity

Each party agrees to use the other party's logo and graphic identity solely for the purposes outlined in this agreement and in accordance with the respective brand guidelines. Any use of the logos or other distinctive marks must be pre-approved in writing by the owning party.



Article 9

Term and Termination

1. The term of this MOA will be three (3) years from the date on which this MOA has been signed by the Parties.
2. Each Party reserves the right to terminate this MOA if such Party is or will be unable to perform the obligations set forth in this MOA, or this MOA no longer serves its purpose.

Article 10

Settlement of Differences

Any differences arising out of the interpretation and/or the-implementation of this MOA shall be resolved amicably through consultation and/or negotiation by the Parties.



Article 11

Amendment

If there are (i) any differences of opinion among the Parties with respect to interpretation of this MOA, or (ii) any other matters to be discussed in furtherance of the purposes of this MOA, such differences or matters will be settled by a working group, and this MOA may be amended in writing by the Parties to reflect the results of the settlement.

Article 12

Protection of Intellectual Property Rights and Disclosure of Information

1. If either Party wishes to disclose confidential data and/or information resulting from the cooperative activities under this MOA to any third party, the disclosing Party must obtain prior consent from the other Party before any disclosure can be made; and
2. Any arrangement arising from this MOA involving intellectual property rights pertaining to research, publication, and/or commercial purposes shall be determined by individual arrangements to be agreed upon by the Parties at the time and included in a formal agreement.

Article 13

Nature of MOA

1. Nothing in this MOA shall be construed as a binding contract among the Parties, save for the obligations stipulated under Article 7.
2. Should the Parties wish to set out their respective rights and obligations, legally binding agreements which stipulate the specific conditions and time periods will be separately negotiated and agreed.

This MOA has been executed in two (2) duplicate originals, and each Party has received one (1) duplicate original, and all originals will be equally valid.


