



## MEMORANDUM OF UNDERSTANDING Between The University of Arizona and Universidad Nacional Agraria La Molina

Through this Memorandum of Understanding ("MOU"), the Arizona Board of Regents for and on behalf of the University of Arizona (hereinafter "U of A"), located 615 N Park Ave, Tucson, AZ 85721Tucson, Arizona, U.S.A., and Universidad Nacional Agraria La Molina (hereinafter "UNALM"), located at Av. La Molina s/n, District of La Molina, department and province of Lima, Peru aim to collaborate on projects and activities which support the mission of each institution, particularly those related to agriculture and natural resources management.

The U of A and UNALM each is a "Party"; collectively, they are the "Parties".

Both Parties intend to seek opportunities to collaborate across a range of activities, including:



- Faculty and scholar mobility;
- Research collaboration;
- Educational collaboration:
- Exchange of scholarly information including library materials and research publications;
- Organization of joint academic and scientific activities, such as seminars and guest lectures.



This MOU is not intended to be a binding agreement between the Parties, but rather a statement of the intentions of the Parties to negotiate the terms and conditions of a formal agreement for mutual cooperation and activities in the future, including responsibilities, schedules, specific provisions for the ownership of intellectual property, as well as financial consideration and any other items deemed necessary for the efficient management of the activity. No confidential or export-controlled information shall be disclosed pursuant to this MOU.

This MOU is subject to cancellation pursuant to Arizona Revised Statutes § 38-511 regarding Conflict of Interest if any person significantly involved in negotiating, drafting, securing or obtaining this MOU for or on behalf of the University of Arizona becomes an employee in any capacity of the other Collaborating Institution or a consultant to the other Collaborating Institution with reference to the subject matter of this MOU while the MOU or any extension thereof is in effect.





The Parties shall designate a coordinator to oversee and facilitate the implementation of this MOU. The U of A designates to Justin Dutram (<u>jdutram@arizona.edu</u>) and UNALM designates to Director of the Interinstitutional Management Office (<u>ogi@lamolina.edu.pe</u>).

This MOU will be in effect for five (5) years from the date it is fully executed. After this initial period, the Parties may re-examine this MOU and make any necessary adjustments based on a mutually agreed-to assessment of the collaboration. This Agreement may be terminated by either Party, with or without case, upon thirty (30) days written notice to the other at any time before the date of expiration. This MOU may be terminated immediately, in whole or in part, in the event that any participant collaborating under this MOU is included in any applicable restricted party screening list.



This MOU may be signed in counterparts, which together will constitute one agreement. If this MOU is signed in counterparts, no signatory to this MOU will be bound until both Parties have duly executed, or caused to be duly executed, a counterpart of this MOU. Each Party may rely on facsimile or electronically transmitted signature pages as if such facsimile or electronically transmitted pages were originals.
